- In accordance with Article 25 of the Financial Regulation applicable to the CTA¹, financial statements for the financial year 2020 were drawn up on the basis of statutory audits.
- 2. The Director's overall implementation of the Centre's budget during the financial year 2020 was such that, on the basis of the financial statements and the statutory audit reports of the CTA for the financial year 2020, the Director should be given a discharge in respect of the implementation of that budget.
- In view of this, the ACP Working Party agreed at its level upon the attached draft Decision on 14 September 2021.

Having taken note of the financial statements of the Technical Centre for Agricultural and Rural Cooperation for the financial year 2020 that ended on 31 December 2020,

Having taken note of the Auditors' reports on the financial statements for the financial year 2020,

Having taken note of the approval of the financial statements of the Technical Centre for Agricultural and Rural Cooperation for the financial year 2020 by the Board of the Centre, based on the examination of the audit report,

Whereas:

- (1) The revenue of the Centre for the financial year 2020 consisted principally of contributions from the European Development Fund, amounting to EUR 13 833 000 on a total of EUR 15 279 000.
- (2) The Director's overall implementation of the Centre's budget during the financial year 2020 were such that the Director should be given a discharge in respect of the implementation of that budget,
