- 1. <u>The General Secretariat of the Council</u> has been informed of the resignation of Mr Orestis MESSIOS, as alternate member of the Management Board of the above Foundation in the governments' representatives category (for Cyprus).
- 2. Under Article 4 of Regulation (EU) 2019/127 of the European Parliament and of the Council establishing the European Foundation for the improvement of living and working conditions (Eurofound), and repealing Council Regulation (EEC) No 1365/75, members of the Management Board are appointed by the Council.

Whereas:

- (1) In it Decision of 9 April 2019² the Council appointed the members and alternate members of the Management Board of the European Foundation for the Improvement of Living and Working Conditions for the period from 1 April 2019 to 31 March 2023.
- (2) A seat as alternate member in the governments' representatives category has fallen vacant as a result of the resignation of Mr Orestis MESSIOS.
- (3) The government of Cyprus has nominated a candidate for the vacant seat,
