Subject: Proposal for a REGULATION OF THE EUROPEAN PARLIAMENT AND OF THE COUNCIL establishing the Creative Europe programme (2021 to 2027) and repealing Regulation (EU) No 1295/2013
- Outcome of the third trilogue

Delegations will find attached the 4-column document for the Creative Europe Regulation following the third trilogue on 12 December 2019.

The items on which a preliminary agreement was confirmed by the co-legislators at the third trilogue correspond to the following lines: 39, 49, 77, 78, 94, 162, 165, 170, 180, 181, 182, 183, 256, 268, 280, 294, 303.

Line 126, for which a preliminary compromise was included in the Council mandate approved by Coreper on 11 December¹, was reopened by the European Parliament in the run-up to the third trilogue pending the reaching of an agreement on the topic of inclusion, and therefore is not among the ones agreed on 12 December.
