I would kindly ask you to initiate the appointment procedure laid down in Article 305 TFEU for the following new nomination to the Committee of the Regions (CoR):

The State Government of Schleswig-Holstein has nominated Mr Claus Christian Claussen, Minister für Justiz, Europa und Verbraucherschutz des Landes Schleswig-Holstein (Minister for Justice, Europe and Consumer Protection of the State of Schleswig-Holstein), as a new alternate member of the CoR for the remainder of the seventh term of office.

The new nomination was necessitated by the departure of his predecessor, Dr Sabine Sütterlin-Waack.

The Federal Government hereby proposes that Mr Claus Christian Claussen be appointed as an alternate member of the CoR for its seventh term of office.
