Subject: Transfer of appropriations No DEC 22/2021 within Section III - Commission
- of the general budget for 2021

1. On 28 October 2021, the Commission submitted to the Council proposal for transfer of appropriations No DEC 22/2021 related to the mobilisation of the European Globalisation Adjustment Fund (EGF/2021/002 IT/Air Italy)¹, in accordance with Article 31(1) of the Financial Regulation².
2. The purpose of this transfer is to move an amount of EUR 3.87 million, in commitment appropriations from Article 30 04 02 (*Reserve for the European Globalisation Adjustment Fund*) to Item 16 02 02 (*European Globalisation Adjustment Fund (EGF)*), as recorded in document 13310/21.
