Subject:	Transfer of appropriations No DEC 28/2021 within Section III - Commission - of the general budget for 2021

---

1. On 29 October 2021, the Commission submitted to the Council proposal for transfer of appropriations No DEC 28/2021 related to the mobilisation of the European Union Solidarity Fund<sup>1</sup>, in accordance with Article 31(1) of the Financial Regulation<sup>2</sup>.
2. The purpose of this proposal is to move an amount of EUR 277.87 million in commitment and payment appropriations from Article 30 04 01 (*Solidarity and emergency aid reserve (SEAR)*) to Item 16 02 01 01 (*Assistance to Member States in relation to events eligible under the European Union Solidarity Fund (EUSF)*).

  - the draft letter in the ANNEX to that effect.
