Statement by Hungary

"Considering the principle of loyal cooperation, Hungary does not wish to hinder cooperation between the EU and the African Union in any way, however we wish to add some remarks and present some of our concerns in our national capacity.

In our view, migratory regulation is a strictly national competence, therefore all states have the right to define their migration policies, protect their borders, and provide protection against criminal networks exploiting the often vulnerable situation of people on the move. States shall avoid, in particular, creating pull factors for illegal migration and thereby generating further opportunities for human traffickers and smugglers.

We also stress that promoting migration does not resolve the socio-economic, political or environmental challenges in countries of origin, and instead, we shall focus our efforts on addressing these root causes through conflict prevention, sustainable development and the safeguarding of human rights.

It is also crucial to highlight, that the COVID-19 pandemic caused an unprecedented health emergency for most countries, which highlighted the fact that the uncontrolled flow of masses of people - in addition to being an extremely serious security threat - also poses serious health risks.

Thus, we would like to dissociate ourselves from the section titled "Migration and Mobility" of the 'joint communiqué', especially from paragraphs 34 and 35. We also would like to dissociate ourselves from paragraph 7, due to the fact, that the Agreement has not yet been concluded, therefore we do not consider it appropriate to call for its implementation.

Further to that, we would like to emphasize that Hungary understands the expression 'gender equality' as referring to the equality between women and men, in line with art. 2 of the Treaty on the European Union and art. 23 of the Charter of Fundamental Rights of the EU. In other instances, Hungary understands the term 'gender' as referring to the biological sexes."

Interpretative note by Poland

"Equality between women and men is enshrined in the treaties of the European Union as a fundamental right. Poland ensures equality between women and men within the framework of the Polish national legal system in accordance with internationally binding human rights instruments and within the framework of fundamental values and principles of the European Union. For these reasons, in place where the joint communiqué refers to gender equality Poland will interpret it as a equality between women and men, according to Article 2 of the Treaty on European Union and the Article 8 of the Treaty on the Functioning of the European Union."

Statements by the Commission

on the legal basis

"The Commission considers it legally incorrect that a Council Decision authorising the opening of negotiations indicates a substantive legal basis.

The Decision authorising the opening of negotiations is premised solely on the existence of conferred powers of the Union and not on a determination of a specific competence. Its effect is limited to authorising the Commission or the High Representative, as the case may be, to use its prerogatives under the EU Treaties in order to start negotiations. The scope of these negotiations is therefore determined by the scope of the powers of the Union. Besides, the freedom of the envisaged treaty partner of the Union as regards the determination of the scope of the negotiations cannot be limited by the Council Decision authorising the opening of the negotiations. Thus, the precise legal basis for the future agreement can only be determined after the content of the agreement is known.

The Commission reserves all its rights in this regard."

"The Commission considers it legally incorrect that a Council Decision authorising the opening of negotiations gives the Council power to issue subsequent negotiation directives during the negotiations, which suggests, contrary to the Treaties and Court's jurisprudence, that negotiation directives would have a binding effect on the negotiator. The Commission reserves all its rights in this regard."
