As regards that Council meeting:

- the Lithuanian delegation requested an item, under "Any other business", on the difficult situation in the pig meat sector;
- the Hungarian delegation requested an item, under "Any other business", on the Joint Declaration of the Ministers of Agriculture of the Visegrad Group (Czech Republic, Hungary, Poland, Slovakia) and Bulgaria, Croatia and Romania on the need for a transparent procedure for the adoption of the CAP strategic plans and to make the new delivery model functional;
- the Slovak delegation requested an AOB on difficulties handling the populations of brown bears and wolves.

d) (new) Planned Delegated act on the taxonomy of economic activities for the purposes of climate change mitigation and adaptation
