- 2. Under Article 4 of Regulation (EU) 2019/127 of the European Parliament and of the Council establishing the European Foundation for the improvement of living and working conditions (Eurofound), and repealing Council Regulation (EEC) No 1365/75, members of the Management Board are appointed by the Council.

## THE COUNCIL OF THE EUROPEAN UNION,

Having regard to Regulation (EU) 2019/127 of the European Parliament and of the Council of 16 January 2019 establishing the European Foundation for the improvement of living and working conditions (Eurofound)<sup>1</sup>, and in particular Article 4 thereof,

### Whereas:

- (1) In its Decisions of 9 April 2019<sup>2</sup>, 25 June 2019<sup>3</sup>, 8 July 2019<sup>4</sup>, 16 September 2019<sup>5</sup> and 14 June 2021<sup>6</sup>, the Council appointed the members and alternate members of the Management Board of the European Foundation for the Improvement of Living and Working Conditions for the period from 1 April 2019 to 31 March 2023.
- (2) A seat as alternate member in the governments' representatives category has fallen vacant as a result of the resignation of Ms María CALLE GARCÍA.
- (3) The government of Spain has nominated a candidate for the vacant seat,
