PROPOSAL FOR THE COMPOSITION OF THE FINNISH DELEGATION TO THE COMMITTEE OF THE REGIONS FOR THE REMAINDER OF THE CURRENT TERM OF OFFICE, FOLLOWING THE OUTCOME OF THE JUNE 2021 LOCAL ELECTIONS IN MAINLAND FINLAND, AND NOTICE OF THE EXTENSION OF OTHER MEMBERS' TERM OF OFFICE

Local elections were held in Finland on 13 June 2021. Following the outcome of those local elections, some changes are needed to the delegation representing mainland Finland at the Committee of the Regions for the remainder of the current term of office.

Finland is represented at the Committee of the Regions by nine (9) full members and nine (9) alternates. Of these nine, eight are from mainland Finland and one is from Åland.

Satu Haapanen, a full member of the Committee of the Regions, and Joonas Honkimaa, an alternate member of the Committee of the Regions, did not stand in the local elections in June 2021. The other members and alternates were re-elected to the local council posts on the basis of which they were appointed to the Committee of the Regions.

At its general meeting on 28 October 2021, the Finnish Government decided to propose candidates for a new member and two new alternate members of the Committee of the Regions for the remainder of the current term of office, as follows:
