- 1. <u>The General Secretariat of the Council</u> has been informed of the resignation of Mr Robert CLOAREC as alternate member of the above Committee in the employers' representatives category (for Sweden)
- 2. Under Article 24 of Regulation (EU) No 492/2011 of the European Parliament and of the Council of 5 April 2011 on freedom of movement for workers within the Union, members and alternate members are appointed by the Council.

3. In accordance with the usual procedure, the Government of Sweden has nominated the following candidate for the remainder of the current term of office, ending on 24 September 2022<sup>1</sup>:

### THE COUNCIL OF THE EUROPEAN UNION.

Having regard to Regulation (EU) No 492/2011 of the European Parliament and of the Council of 5 April 2011 on freedom of movement for workers within the Union<sup>2</sup>, and in particular Articles 23 and 24 thereof.

### Whereas:

- (1) In its Decisions of 21 September 2020<sup>3</sup>, 11 December 2020<sup>4,5</sup>, 13 April 2021<sup>6</sup>, 21 June 2021<sup>7</sup> and 21 September 2021<sup>8</sup>, the Council appointed the members and alternate members of the Advisory Committee on Freedom of Movement for Workers for the period ending on 24 September 2022.
- (2) A seat as alternate member in the employers' representatives category has fallen vacant as a result of the resignation of Mr Robert CLOAREC.
