## 1. CORRECTIONS IN RELATION TO ICCAT

### EXPLANATORY NOTE

The corrections include revised Tables A and B on bluefin tuna farming in Annex VI, Section 6 of the Commission Proposal, as well as corrections of errors in the fishing opportunities table for bigeye tuna in Annex ID of the Commission Proposal.

The Commission proposes to correct Tables A and B in Annex VI, Section 6 to represent the figures before the transfers conducted between some Member States in the course of 2021. These transfers were limited to 2021 and should not be referred to with respect to other years. As those figures may change in the course of 2022 subject to farming plans, the Commission proposes to correct the wording in the footnote in Table B. Moreover, the Commission proposes to correct the fishing opportunities table for bigeye tuna in order to enable future adjustments to the individual quotas of Member States in 2022 for this stock as explained in recital (28) of the Commission Proposal.

### AMENDMENTS TO ANNEX ID

In Annex ID, the seventh fishing opportunities table for bigeye tuna is amended as follows:
