The SCA agreed that its Chair should write to the Chair of the EP Committee on Agriculture and Rural Development informing him that, should the EP adopt its position at first reading in line with the text of the political agreement (as annexed to document 14752/21) then, subject to revision by the lawyer/linguists of both institutions, the Council would, in accordance with Article 294(4) TFEU, approve the European Parliament's position and the act would be adopted in the wording corresponding to the European Parliament's position. It noted the intention of FI to vote against and to enter a statement in the minutes of the Council meeting that would adopt the Regulation.
