The Council Legal Service clarified that the voting rule in the Council for the approval of the Joint Declaration of the European Parliament, the Council and the Commission on the EU legislative priorities for 2022 (document 14479/21), referred to in point 7 of the Interinstitutional Agreement of 13 April 2016 on Better Law Making is reinforced qualified majority. This is the voting rule applicable in the Council when it concludes an interinstitutional agreement under Article 295 TFEU.

The Council approved the Joint Declaration. Hungary and Poland voted against and presented statements.

**Legislative Programming: Joint Declaration on the EU legislative priorities for 2022**

*Approval*

**STATEMENT BY HUNGARY**

“Hungary agrees with the objective to continue to defend the rule of law as well as to protect and strengthen our democracy across the Union and defend our common European values.

Nevertheless, in line with Hungary’s longstanding political and legal position we underline that any instrument can only support the strengthening of the rule of law, if it is duly based on the Treaties and applied in accordance with the respective provisions of Union law. The application of existing instruments cannot lead to double standards and should duly respect the principles of conferral, equal treatment and mutual trust as well as the constitutional systems, legal heritage and national identity of Member States as foreseen in the Treaties.

The value of the rule of law should not be used to exert political pressure in ways that do not comply with the basic requirements of rule of law themselves.”

**STATEMENT BY POLAND**

“Poland agrees with the objective to continue to defend the rule of law as well as to protect and strengthen our democracy across the Union and defend our common European values.

Nevertheless, in line with Poland’s longstanding political and legal position we underline that any instrument can only support the strengthening of the rule of law, if it is duly based on the Treaties and applied in accordance with the respective provisions of Union law. The application of existing instruments cannot lead to double standards and should duly respect the principles of conferral, equal treatment and mutual trust as well as the constitutional systems, legal heritage and national identity of Member States as foreseen in the Treaties.

**STATEMENT BY AUSTRIA, GERMANY, AND LUXEMBOURG**
