THE COUNCIL OF THE EUROPEAN UNION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Council Decision 2003/C 218/01 of 22 July 2003² on the setting up of an Advisory Committee on Safety and Health at Work, and in particular Article 3 thereof,

Whereas:

- (1) By its Decisions of 12 March 2019³, 15 April 2019⁴, 14 May 2019⁵, 27 May 2019⁶ and 8 July 2019⁷ the Council appointed the members and alternate members of the Advisory Committee on Safety and Health at Work for the period ending on 28 February 2022.
- (2) A seat as member in the trade unions' representatives category has fallen vacant as a result of the resignation of Ms Ingrid REIFINGER.
- (3) The government of Austria has nominated a candidate for the vacant seat,
