- (1) In accordance with Council Decision (EU) 2022/...¹⁺, the Agreement in the form of an Exchange of Letters between the European Union and the Republic of Mauritius concerning the extension of the Protocol setting out the fishing opportunities and the financial contribution provided for by the Fisheries Partnership Agreement between the European Union and the Republic of Mauritius ('the Agreement in the form of an Exchange of Letters') was signed on ...⁺⁺, subject to its conclusion at a later date.
