## THE COUNCIL OF THE EUROPEAN UNION,

Having regard to Regulation (EU) 2019/126 of the European Parliament and of the Council establishing the European Agency for Safety and Health at Work (EU-OSHA), and repealing Council Regulation (EC) No 2062/94<sup>1</sup>, and in particular Article 4 thereof,

#### Whereas:

- In its Decisions of 9 April 2019<sup>2</sup>, 6 June 2019<sup>3,4</sup> and 8 July 2019<sup>5</sup>, the Council appointed the members and alternate members of the Management Board of the European Agency for Safety and Health at Work for the period from 1 April 2019 to 31 March 2023.
- (2) A seat as alternate member in the employers' representatives category has fallen vacant as a result of the resignation of Ms Piia ZIMMERMANN.
- (3) The employers' organisation BusinessEurope has nominated a candidate for the vacant seat,
