Subject:	Management Board of the European Agency for Safety and Health at Work Appointment of Ms Marina PRELEC, member for Croatia, in place of Ms Žanna ŠOSTAK, who has resigned

1. The General Secretariat of the Council has been informed of the resignation of Ms Žanna ŠOSTAK, as member of the Management Board of the above Agency in the governments' representatives category (for Croatia).
2. Under Article 4 of Regulation (EU) 2019/126 of the European Parliament and of the Council establishing the European Agency for Safety and Health at Work (EU-OSHA), and repealing Council Regulation (EC) No 2062/94, members of the Management Board are appointed by the Council.

3. In accordance with the usual procedure, the government of Croatia has nominated the following candidate for this seat for the remainder of the current term of office, ending on 31 March 2023:

THE COUNCIL OF THE EUROPEAN UNION,

Having regard to Regulation (EU) 2019/126 of the European Parliament and of the Council establishing the European Agency for Safety and Health at Work (EU-OSHA), and repealing Council Regulation (EC) No 2062/94¹, and in particular Article 4 thereof,

Whereas:

- (1) In its Decisions of 9 April 2019², 6 June 2019^{3,4} and 8 July 2019⁵, the Council appointed the members and alternate members of the Management Board of the European Agency for Safety and Health at Work for the period from 1 April 2019 to 31 March 2023.
- (2) A seat as member in the governments' representatives category has fallen vacant as a result of the resignation of Ms Žanna ŠOSTAK.
- (3) The government of Croatia has nominated a candidate for the vacant seat,
