Following Russia's invasion of Ukraine on 24 February 2022, the humanitarian situation in the country is deteriorating rapidly. Humanitarian assistance partners are already responding all over the country and are scaling up their response. Additional funding is requested urgently while Ukraine is facing an unprecedented humanitarian catastrophe.

As of mid-March, the number of people stranded in conflict-affected areas has risen to 12,7 million. The UN Refugee Agency estimates that 1,9 million people are newly internally displaced and over 2,8 million people have fled the country. According to United Nations Office for the Coordination of Humanitarian Affairs, the most concerning humanitarian situation is seen in the biggest cities currently under siege or nearly completely cut off (including Kiev, Mariupol, Kharkiv and Kherson) and throughout the contact line in Donbas.

Emergency assistance is already delivered in various parts of the country, including food and non-food items, emergency shelter support, water, hygiene kits, health and protection support. On 1 March 2022, the UN launched an appeal of USD 1,7 billion.

The present transfer proposes to reinforce the Humanitarian Aid by **EUR 50 million** in commitment and **EUR 40 million** in payment appropriations to help the affected people with food and non-food items, emergency medical services, critical medicines, health supplies and equipment, psychosocial support, child protection, drinking water and hygiene kits, shelter, and protection for the persons affected by the conflict.

As of mid-March, the overall implementation rate of commitment appropriations of the humanitarian aid chapter 14 03 was at 89% of available appropriations and the implementation in payment appropriations was at 8,9%. On 12 March 2022, EUR 90,7 million have already been contracted for Ukraine. The Commission has identified available resources in Heading 6 for EUR 11 million in commitment and EUR 1 million in payment appropriations from the Instrument for Pre-Accession. In addition, it is requested to mobilise the Solidarity and Emergency Aid Reserve for a total of EUR 39 million in commitment and payment appropriations.

- (a) assistance to respond to emergency situations resulting from major disasters that are covered by the European Union Solidarity Fund, the objectives and scope of which are set out in Council Regulation (EC) No 2012/2002; and
- (b) rapid responses to specific emergency needs within the Union or in third countries following events which could not be foreseen when the budget was established, in particular for emergency responses and support operations following natural disasters not covered by point (a), man-made disasters, humanitarian crises in cases of large-scale public health, veterinary or phytosanitary threats, as well as in situations of particular pressure at the Union's external borders resulting from migratory flows, where circumstances so require.

### d) Detailed grounds for the increase

In view of the humanitarian situation rapidly deteriorating in Ukraine, EUR 50 million in commitment and EUR 40 million in payment appropriations are needed to help the affected people with food and non-food items, emergency medical services, critical medicines, health supplies and equipment, psycho-social support, child protection, drinking water and hygiene kits, shelter, and protection for the persons affected by the conflict.

Only part of the necessary reinforcement can be covered by available resources in Heading 6. Therefore, the Commission requests the mobilisation of the Solidarity and Emergency Aid Reserve for a total of EUR 39 million in commitment and payment appropriations.

In view of the humanitarian situation rapidly deteriorating in Ukraine, EUR 50 million in commitment and EUR 40 million in payment appropriations are needed to help the affected people with food and non-food items, emergency medical services, critical medicines, health supplies and equipment, psycho-social support, child protection, drinking water and hygiene kits, shelter, and protection for the persons affected by the conflict.

The Commission has identified available redeployments in Heading 6 for EUR 11 million in commitment and EUR 1 million in payment appropriations from the Instrument for Pre-Accession.
