THE HEADS of STATE or GOVERNMENT of the Contracting Parties to the Treaty on Stability, Coordination and Governance in the Economic and Monetary Union whose currency is the euro,

Having regard to the Treaty on Stability, Coordination and Governance in the Economic and Monetary Union, and in particular Article 12 thereof,

Whereas:

- (1) Article 12 of the Treaty on Stability, Coordination and Governance in the Economic and Monetary Union provides that the President of the Euro Summit is to be appointed by the Heads of State or Government of the Contracting Parties whose currency is the euro by simple majority at the same time as the European Council elects its President and for the same term of office.
- (2) On 2 July 2019, Mr Charles MICHEL was appointed President of the Euro Summit for the period from 1 December 2019 until 31 May 2022.
- (3) The European Council re-elected its President at its meeting on 24 March 2022.
- (4) A President of the Euro Summit should be appointed,

HAVE ADOPTED THIS DECISION:

Sole Article

Mr Charles MICHEL is hereby reappointed President of the Euro Summit for the period from 1 June 2022 until 30 November 2024.
