# PRESIDENCY OF THE COUNCIL OF MINISTERS Resolution of the Council of Ministers No 29/2022

Summary: Proposal to the Council of the European Union for the appointment of two members and five alternate members to the Committee of the Regions for the current five-year period

The members of the Committee of the Regions of the European Union and their alternates, in accordance with Article 300 of the Treaty on the Functioning of the European Union (TFEU), are representatives of regional and local bodies who either hold a regional or local authority electoral mandate or are politically accountable to an elected assembly.

In accordance with Article 305, third paragraph, of the TFEU, the term of office of members of the Committee of the Regions of the European Union terminates when the mandate on the basis of which they were proposed comes to an end.

Since the mandates of Fernando Medina Maciel Almeida Correia as Mayor of Lisbon, José Maria da Cunha Costa as Mayor of Viana do Castelo, Luís Manuel Santos Correia as Mayor of Castelo Branco, Paulo Jorge Frazão Batista dos Santos as Mayor of Batalha, and Rui Miguel da Silva André as Mayor of Monchique came to an end following the municipal elections on 26 September 2021, their terms of office as members and alternate members of the Committee of the Regions correspondingly terminate.

Since the mandate of Pedro Miguel Amaro de Bettencourt Calado as Vice-President of the Regional Government and for Parliamentary Affairs of the Regional Government of the Autonomous Region of Madeira has also come to an end, his term of office as alternate member of the Committee of the Regions correspondingly terminates.

In view of the previous nominations approved by Resolutions of the Council of Ministers No 192/2019 of 16 December 2019, No 104-A/2020 of 27 November 2020, and 10/2021 of 10 February 2021, it is now appropriate for a new proposal to be made in order to ensure the proper representation, since it is proposed that Luís Miguel Correia Antunes, who was re-elected in the abovementioned municipal elections as Mayor of Lousã, move from alternate member to member of the Committee of the Regions.

The self-governing bodies of the Autonomous Region of Madeira and the National Association of Portuguese Municipalities have been heard.

#### Consequently:

In accordance with Article 199(g) of the Constitution, the Council of Ministers hereby resolves to:

- 1. propose to the Council of the European Union the appointment as members of the Committee of the Regions of the European Union of:
  - (a) Luís Miguel Correia Antunes, Mayor of Lousã;
  - (b) José Manuel Pereira Ribeiro, Mayor of Valongo;
- 2. propose to the Council of the European Union the appointment as alternate members of the Committee of the Regions of the European Union of:
  - (a) Rogério Andrade Gouveia, Regional Secretary for Finance of the Government of the Autonomous Region of Madeira;
  - (b) Gonçalo Nuno Bértolo Gordalina Lopes, Mayor of Leiria;
  - (c) Luís Carlos Piteira Dias, Mayor of Vendas Novas;
  - (d) Pedro Alexandre Antunes Faustino Pimpão dos Santos, Mayor of Pombal;
  - (e) Rogério Conceição Bacalhau Coelho, Mayor of Faro;
- 3. publish the updated list of members and alternate members proposed to the Council of the European Union in annex to this resolution, of which it forms an integral part;
- 4. decide that this resolution shall take effect on the day of its approval.
