- 1. The General Secretariat of the Council has been informed of the resignation of Ms Maruša GORTNAR as member of the Management Board of the European Institute for Gender Equality in the government representatives category (for Slovenia).
- 2. Article 10 of Regulation (EC) No 1922/2006 of 20 December 2006¹ provides, inter alia, that the Council should appoint 18 members, as well as alternates, of the Management Board of the European Institute for Gender Equality for a period of three years.

Whereas:

- (1) By its Decision of 27 May 2019³ the Council appointed the members and alternate members of the Management Board of the European Institute for Gender Equality, for the period ending on 31 May 2022.
- (2) A member's seat in the government representatives category has fallen vacant as a result of the resignation of Ms Maruša GORTNAR.
