#### Statement by Austria

"Austria supports the compromise text on the COVID certificate of the European Union in principle, but would like to put the following statement on record:

- The joint development of the DCC is an unprecedented digitization project that demonstrates the possibilities for fast and broad cooperation among EU member states. Until then, it was unthinkable to develop a common technical infrastructure - including the associated Regulation in only 3 months, which is available to more than 400 million EU citizens. The way, how to implement the certificate digitally was left open to Member States given the short time frame.
- Due to the rapid implementation of the systems, Austria has built on existing digital systems, such as the e-vaccination passport (eImpfpass) or the EMS. The Austrian eImpfpass is designed in a way to ensure the quality of the registered vaccinations.

Accordingly, entries and additions can only be made by authorized bodies (physicians, public health officers) in order to ensure the highest possible data quality in terms of medical documentation. In addition, the question of liability must also be taken into account. Some authorities are already refusing to register vaccinations due to concerns about liability in the event of incorrect facts being entered. In addition to the interoperability of the certificates, the prevention of fraud and forgery is also at the center of the EU Regulation, which is why special attention should also be paid to this.

- Although a uniform procedure for the registration of vaccination certificates and the issuance of certificates at EU level is desirable, we see Recital 3 of the proposal as extremely critical.
- From a medical point of view, it is essential to establish a quality network in terms of data quality on the one hand and to take into account the medical opinion when issuing certificates on the other hand. Therefore, it is necessary to define minimum intervals between vaccinations (especially the third dose) at EU level. Since some topics such as minimum intervals or cross-vaccination could not (yet) be taken into account when the Regulation was drafted last year, it now seems necessary to set the necessary minimum standards at EU level. In the view of AT, the DCC should not only represent a vaccination certificate, but also prove a low epidemiological risk this is how DCCs have already been used in recent months. According to AT, it is not appropriate to deviate from this central benefit of the DCC. For this purpose, minimum intervals are to be defined, since the system otherwise differs only slightly from the analogous international vaccination certificate of WHO.
- According to the Austrian understanding, recital 3 states that a certificate with further coding must be issued for each vaccination, although the required minimum intervals for immunity maturation (minimum interval to allow the optimal effect of the vaccination) is not given. For example, three vaccinations could be administered on three consecutive days to take advantage of a "booster" certificate. This problem should be prevented with the introduction of minimum intervals, especially since control of intervals between vaccinations often cannot be adequately ensured when vaccinations are administered in different Member States. In addition, this approach can prevent the need to present and verify all underlying certificates as well in order to determine the immune status in case of a possible verification of the certificates."

#### Statement by the Commission

on medicines supply to Cyprus, Ireland and Malta

"The withdrawal of the United Kingdom from the Union has posed particular challenges for those Member States (Cyprus, Ireland and Malta) that during many years were being supplied with medicines from or through parts of the United Kingdom.

The Commission recognises the progress that has been made by Cyprus, Ireland and Malta and industrial operators to implement the necessary changes to facilitate the ongoing supply of medicines following the United Kingdom's withdrawal from the EU.

In order to ensure a long-term security of supply of medicines, the Commission stresses the need for enhanced efforts of all concerned parties in fostering the adaptation of the supply chains to the situation after the United Kingdom's withdrawal.

The Commission is fully committed to accompanying Cyprus, Ireland and Malta in their efforts towards phasing out the temporary derogations provided for in Directive [XXX] and Regulation [XXX] within three years.

To that end, the Commission will, in accordance with Union law and in full respect of the distribution of competences between the Union and Member States in the area of medicines for human use, continuously follow developments in the concerned Member States and will closely accompany the competent authorities of Cyprus, Ireland and Malta in their efforts to decrease the dependency of their domestic markets on the supply with medicinal products from or through parts of the United Kingdom other than Northern Ireland.

The Commission will invite the competent authorities of Cyprus, Ireland and Malta to provide it, on a regular basis, with information on these efforts.

Taking this information into account, the Commission will report in writing to the European Parliament and the Council within 18 months from the date of entry into force of Directive [XXX] and Regulation [XXX] on the progress accomplished in Cyprus, Ireland and Malta towards the complete phasing out of the derogations and the actions of the Commission to closely accompany the competent authorities of those Member States in that regard. The Commission will remind the industrial operators concerned who still need to make changes to their supply chains that they urgently should make the necessary adaptations to ensure access to medicines in the smaller markets. In this context, the Commission will monitor the progress made by operators involved in the supply of medicines in these Member States regarding their ability to fulfil those requirements of Union law from which Directive [XXX] and Regulation [XXX] provide for temporary derogations.

In addition and beyond these immediate and necessary steps, as announced in the "Pharmaceutical Strategy for Europe"<sup>1</sup>, the Commission will make proposals by the end of 2022 to revise the pharmaceutical legislation of the Union. These proposals will seek to provide longer-term structural solutions, in particular, to the issue of access to medicines, with special attention to enhancing security of supply and addressing risks of shortages in the smaller markets of the Union."

The Commission wishes to remind that the Court of Justice has explicitly expressed this position in paragraph 293, in paragraph 305, as well as in the operative part of Opinion 2/15. The Commission therefore considers that the revised recital 3 of the Council Decision does not accurately reflect the substance of the Opinion of the Court as regards the delimitation of competences in the field of investment dispute settlement."
