"REGULATION OF THE EUROPEAN PARLIAMENT AND OF THE COUNCIL amending Regulation (EU) 2018/1862 on the establishment, operation and use of the Schengen Information System (SIS) in the field of police cooperation and judicial cooperation in criminal matters as regards the entry of alerts by Europol"

During the meeting, only the text of the base language is discussed and finalised. On that basis, and taking into account the accepted comments, the other languages are aligned.

The remote presence (via videoconference) of experts at the meeting is desirable.

Your attention is drawn to the following:
