Whereas:

- (1) In accordance with Council Decision (EU) .../...¹⁺, the Agreement between the European Union, of the one part, and the Government of the Faroe Islands, of the other part, on the participation of the Faroe Islands in Union programmes ('the Agreement') was signed on behalf of the Union on ...⁺⁺, subject to its conclusion at a later date.
- The objectives of the Agreement are to establish a lasting framework for cooperation between the Union and the Faroe Islands and to set out the terms and conditions for the participation of the Faroe Islands in the Union programmes which are opened for their participation in accordance with the basic acts establishing Union programmes as defined in the Agreement. Under the Agreement, the Union will carry out cooperation measures with the Faroe Islands pursuant to Article 212 of the Treaty on the Functioning of the European Union. Pursuant to Article 3 of the Agreement, the specific terms and conditions for the participation of the Faroe Islands in any Union programme or activity are subject to the adoption of protocols.

- (3) Horizon Europe, the Framework Programme for Research and Innovation for the period 2021–2027, was established by Regulation (EU) 2021/695 of the European Parliament and of the Council¹. The Protocol on the association of the Faroe Islands to Horizon Europe the Framework Programme for Research and Innovation (2021–2027) was negotiated in parallel to the Agreement and, pursuant to Article 15(9) of the Agreement, forms an integral part thereof.

Regulation (EU) 2021/695 of the European Parliament and of the Council of 28 April 2021 establishing Horizon Europe – the Framework Programme for Research and Innovation, laying down its rules for participation and dissemination, and repealing Regulations (EU) No 1290/2013 and (EU) No 1291/2013 (OJ L 170, 12.5.2021, p. 1).

Article 1

The Agreement between the European Union, of the one part, and the Government of the Faroe Islands, of the other part, on the participation of the Faroe Islands in Union programmes ('the Agreement') is hereby approved on behalf of the Union.

Article 2

The President of the Council shall, on behalf of the Union, give the notification provided for in Article 15(1) of the Agreement.

Article 3

The European Commission shall represent the Union within the Joint Committee set up pursuant to Article 14 of the Agreement.

Article 4

This Decision shall enter into force on the date of its adoption.
