Following the request from several delegations to have further time to examine the revised version of the text, the working party will exceptionally reconvene on the above date in order to finalise from a legal and linguistic point of view the English (EN) language version of:

"REGULATION OF THE EUROPEAN PARLIAMENT AND OF THE COUNCIL on the European Health Data Space"

Due to the length of the text and the challenging nature of the revision, the meeting will start at 9h30 and will continue as long as is necessary to examine the entirety of the Regulation.

Your comments relating to the EN language version were to be sent to the President of the working party and the EN team of the DQL (see following table) by **18/10, in accordance with the recommendations that accompanied the transmission of the text on 9/10**. Other language versions were sent out on **22/10** and comments on those other language versions must be sent to the relevant team of the DQL (see following table) by **6/11 at 17h00**.

Linguistic comments submitted after these deadlines cannot be taken into account.

During the meeting of the working party, only the text of the EN language version is discussed and finalised. On that basis, and taking into account the accepted comments, the other language versions are aligned.

In order to optimise the meeting and the relatively short time available to finalise and align all the language versions, we kindly invite you to concentrate on the outstanding points, to avoid reopening issues previously discussed and agreed, to refrain from questioning minor corrections that fall clearly within the remit of legal linguistic revision and to propose alternative drafting if you have a serious objection to a particular point.

Your attention is drawn to the following:

- In order to ensure the smooth running of the meeting, it is essential that all delegates follow the specific pagination of the text of the EN language version. In addition, please ensure that you use the version showing track changes and remove the "balloon view" function.
