## **COUNCIL DECISION**

**on the signing, on behalf of the European Union, of the Enhanced Partnership and Cooperation Agreement between the European Union and its Member States, of the one part, and the Republic of Uzbekistan, of the other part**

THE COUNCIL OF THE EUROPEAN UNION,

Having regard to the Treaty on the Functioning of the European Union, and in particular Articles 207 and 209, in conjunction with Article 218(5),

Having regard to the proposal by the European Commission,

Whereas:

- (1) On 16 July 2018, the Council authorised the opening of negotiations with the Republic of Uzbekistan for an Enhanced Partnership and Cooperation Agreement,
- (2) Building upon the desire of the Parties to strengthen and widen relations in an ambitious and innovative way, the negotiation of the Enhanced Partnership and Cooperation Agreement ('the Agreement') was successfully finalised by the initialling of the Agreement on 6 July 2022,
- (3) Therefore, the Agreement should be signed on behalf of the European Union,
- (4) In view of the need to apply the Agreement ahead of its entry into force following ratifications by the Member States, the Agreement should be applied on a provisional basis, pending the completion of the procedures necessary for its entry into force,

HAS ADOPTED THIS DECISION:

### *Article 1*

1. The signing of the Enhanced Partnership and Cooperation Agreement between the European Union and its Member States, of the one part, and the Republic of Uzbekistan, of the other part, is hereby approved on behalf of the European Union, subject to the conclusion of the said Agreement.<sup>1</sup>

### *Article 2*

Pending its entry into force, in accordance with Article 345 of the Agreement and subject to the notifications provided for therein, the Agreement shall be applied provisionally between the Union and the Republic of Uzbekistan.
