## **'I/A' ITEM NOTE**

Subject:	COUNCIL DECISION on the position to be taken on behalf of the European Union in the sixty-eighth session of the Commission on Narcotic Drugs on the scheduling of substances under the Single Convention on Narcotic Drugs of 1961, as amended by the 1972 Protocol, and the Convention on Psychotropic Substances of 1971  - Adoption

- The United Nations (UN) Single Convention on Narcotic Drugs of 1961, as amended by the 1972 Protocol, and the UN Convention on Psychotropic Substances of 1971 ('the Conventions') are the main international drug control treaties, together with the UN Convention against Illicit Traffic in Narcotic Drugs and Psychotropic Substances of 1988.
- 2. States parties to the Conventions are required to ensure that the mandatory control measures are applied to the substances listed in the Schedules annexed to the Conventions. The purpose of this listing is to control and limit the use of these drugs according to a classification of their therapeutic value, risk of abuse and health dangers, and to minimise the diversion of precursor chemicals to illegal drug manufacturers.

- 3. Decisions to change the scope of control of substances are taken by the Commission on Narcotic Drugs (CND), through decisions to make changes to the Schedules of the Conventions, on the basis of recommendations by the World Health Organisation.
- 4. At its 68th session taking place from 10 to 14 March 2025 in Vienna, the CND is to adopt decisions on the scheduling of substances under the Conventions.
- 5. On 13 January 2025, the Commission presented a proposal for a Council Decision on the position to be taken, on behalf of the European Union, in the 68th session of the CND on the scheduling of substances under the Conventions (ST 5271/25 + ADD 1).
- 6. The Commission proposal was analysed at the meeting of the Horizontal Working Party on Drugs (HDG) on 22 January 2025. The revised version of the proposal, as set out in ST 5810/25, was endorsed by the HDG at its meeting on 11-12 February 2025, with one delegation indicating its intention to abstain upon the adoption of the Council Decision.
- 7. In view of the above, the Permanent Representatives Committee is requested to invite the Council to adopt, as an 'A' item at one of its forthcoming sessions, Council Decision, as finalised by the legal-linguistic experts and set out in ST 6155/25, on the position to be taken, on behalf of the European Union, in the 68th session of the Commission on Narcotic Drugs on the scheduling of substances under the Single Convention on Narcotic Drugs of 1961, as amended by the 1972 Protocol, and the Convention on Psychotropic Substances of 1971.
