Subject: COUNCIL DECISION on the signing, on behalf of the European Union, of the Agreement between the European Union and the Republic of Lebanon, in the form of an Exchange of Letters, amending and supplementing the Agreement for scientific and technological cooperation between the European Union and the Republic of Lebanon setting out the terms and conditions for the participation of the Republic of Lebanon in the Partnership for Research and Innovation in the Mediterranean Area (PRIMA)

THE COUNCIL OF THE EUROPEAN UNION,

Having regard to the Treaty on the Functioning of the European Union, and in particular
Article 186, in conjunction with Article 218(5) thereof,

Having regard to the proposal from the European Commission,

Whereas:

- (1) Decision (EU) 2017/1324 of the European Parliament and of the Council¹ established the Partnership for Research and Innovation in the Mediterranean Area (PRIMA) under Horizon 2020, established by Regulation (EU) No 1291/2013 of the European Parliament and of the Council², for a period until 31 December 2028.
- (2) Lebanon is one of 19 Participating States in PRIMA having concluded an agreement for scientific and technological cooperation setting out the terms and conditions for its participation in PRIMA³ ('the PRIMA Agreement'). The PRIMA Agreement is to remain in force for as long as Decision (EU) 2017/1324 is in force.

- (3) Decision (EU) 2024/1167 of the European Parliament and of the Council⁴ extended PRIMA's overall duration until 31 December 2031 and provided for Lebanon to continue to participate in PRIMA under Horizon Europe⁵, subject to the conclusion of an agreement, in the form of an exchange of letters, amending and supplementing the PRIMA Agreement.
- (4) Since Lebanon has expressed its interest in continuing to participate in PRIMA under Horizon Europe, it should formally accept the updated terms and conditions for such participation.

- (5) To that end, on 9 November 2023, the Council adopted Decision (EU) 2023/2621⁶ authorising the Commission to negotiate an agreement, in the form of an exchange of letters, amending and supplementing the PRIMA Agreement, setting out the terms and conditions for the participation of Lebanon in PRIMA under Horizon Europe ('the Agreement').
- (6) The negotiations were successfully concluded by the initialling of the Agreement on 22 July 2024.
- (7) Therefore, the Agreement should be signed,

HAS ADOPTED THIS DECISION:

Article 1

The signing of the Agreement between the European Union and the Republic of Lebanon, in the form of an Exchange of Letters, amending and supplementing the Agreement for scientific and technological cooperation between the European Union and the Republic of Lebanon setting out the terms and conditions for the participation of the Republic of Lebanon in the Partnership for Research and Innovation in the Mediterranean Area (PRIMA), is hereby authorised on behalf of the Union, subject to the conclusion of the said Agreement⁷⁺.

Article 2

This Decision shall enter into force on the date of its adoption.
