- On 3 March 2025, the Court of Justice of the European Union (CJEU) submitted to the Council proposal for transfer of appropriations No 1-DEC/2025, in accordance with Articles 31 and 49 of the Financial Regulation¹.
- 2. The purpose of this proposal is to transfer from Chapter 10 0 (*Provisional appropriations*) an amount of EUR 1 878 000 to Item 1 2 0 0 (*Remunerations and allowances*) and an amount of EUR 623 000 to Item 4 0 0 (*Other staff and external services*).

On 6 February 2025, the CJEU adopted a decision establishing the Housing allowance for some categories of its staff members residing in Luxembourg, based on the common model for all Luxembourg based institutions. Therefore, the CJEU proposes to increase the above mentioned lines in order to cover the payment of that Housing allowance, such as endorsed by the budgetary authority in the EU budget 2025.
