#### **PROCEDURAL ACT 2024/01/ECRB-EnC AMENDING AND REPLACING THE PROCEDURAL ACT 2019/01/ECRB-EnC ON THE INTERNAL RULES OF PROCEDURE OF THE ECRB**

The position to be taken on behalf of the Union in the Ministerial Council is to approve the following draft Procedural Act amending and replacing the Procedural Act on the Internal Rules of Procedure of the ECRB:

#### **Procedural Act No 1/2024 of the Regulatory Board of the Energy Community**

**2024/01/ECRB-EnC of xx XX 2024 amending and replacing the Procedural Act 2019/01/ECRB-EnC**

THE REGULATORY BOARD OF THE ENERGY COMMUNITY,

Having regard to the Treaty establishing the Energy Community (hereafter "Energy Community Treaty") and in particular Article 60, 86 and 87 thereof,

Having regard to the proposal, made by the Energy Community Secretariat,

Acting in accordance with the procedure laid down in Article 82 and 83 of the Energy Community Treaty,

Acting in accordance with the procedure laid down in Article 13.3 of the Internal Rules of Procedure of the Regulatory Board of the Energy Community, Procedural Act No. 01/2007 amended by Procedural Acts 2009/01, 2012/01, 2013/02, 2015/01 and 2019/01.

HAS DECIDED AS FOLLOWS:

#### *Article 1*

Procedural Act No. 2024/01/ECRB-EnC amending and replacing the Internal Rules of Procedure of the Regulatory Board of the Energy Community as laid down in the Annex to this Act is hereby adopted.

#### *Article 2*

This Procedural Act is addressed to the members of the Energy Community Regulatory Board.

#### *Article 3*

The Energy Community Secretariat shall make this Procedural Act and its Annex available to all Parties and institutions under the Energy Community Treaty within seven days after its adoption.

*Article 4*

This Procedural Act shall enter into force upon adoption.
