- agreement in principle on the Council Decision on the conclusion of the abovementioned
  Protocol on behalf of the Union, and agreement to forward it to the European Parliament for its consent:
- adoption of the Council Regulation on the allocation of fishing opportunities under the abovementioned Protocol.
