Delegations are hereby informed that the written procedure opened by CM 2465 of 23 April 2025 was successfully completed on 25 April 2025, and that:

- 1. All delegations voted in favour of the use of the written procedure for the approval of the abovementioned legal acts (doc. 7375/25 + COR 1, 7374/25 and 7387/25 + COR 1).
- 2. All delegations voted in favour of the:
  - adoption of the Council Decision on the signing, on behalf of the Union, and provisional application of the Protocol on the implementation of the Fisheries Partnership Agreement between the Republic of Cote d'Ivoire and the European Community (2025-2029), as set out in document 7375/25 + COR1;
  - agreement in principle on the Council Decision on the conclusion of the abovementioned Protocol on behalf of the Union, as set out in document 7374/25, and agreement to forward it, together with the text of the protocol (doc. 7042/25 + COR 1 + COR 2 + COR 3) to the European Parliament for its consent;
  - adoption of the Council Regulation on the allocation of fishing opportunities under the abovementioned Protocol, as set out in document 7387/25 + COR 1.

The required qualified majority has been reached. Therefore, the Council Decision on signing and provisional application and the Council Regulation on the allocation of fishing opportunities are adopted, agreement in principle has been reached on the Council Decision on conclusion, and the latter will be forwarded, together with the text of the protocol, to the European Parliament for its consent.

The Council has also taken note of the statement by the Commission in ST 8283/2025. This statement will be included in the summary of acts adopted by the written procedure as a statement to be entered in the Council minutes, in accordance with the third subparagraph of Article 12(1) of the Council's Rules of Procedure.
