## THE COUNCIL OF THE EUROPEAN UNION,

Having regard to the Treaty on the Functioning of the European Union, and in particular Article 305 thereof,

Having regard to Council Decision (EU) <u>2019/852</u> of 21 May 2019 determining the composition of the Committee of the Regions<sup>1</sup>,

Having regard to the proposal of the Government of Ireland,

#### Whereas:

- (1) Pursuant to Article 300(3) of the Treaty, the Committee of the Regions is to consist of representatives of regional and local bodies who either hold a regional or local authority electoral mandate or are politically accountable to an elected assembly.
- On 10 December 2024, the Council adopted Decision (EU) 2025/71<sup>2</sup>, appointing the (2) members and alternate members of the Committee of the Regions for the period from 26 January 2025 to 25 January 2030.
- (3) A member's seat on the Committee of the Regions has become vacant following the end of the national mandate on the basis of which Ms Eileen LYNCH was proposed for appointment.
- (4) The Government of Ireland has proposed Ms Bridin MURPHY, representative of a local body who holds a local authority electoral mandate, Councillor of Wexford County Council, as a member of the Committee of the Regions for the remainder of the current term of office, which runs until 25 January 2030.
