Gavi's origin story: 2000



Urgent global health challenge:

children in lower-income countries were not receiving powerful new vaccines



Market failures in lower-income countries:

manufacturers were focused on low-volume/ high-priced markets – not seeing huge market potential for affordable products



Broad new alliance:

including industry, developed and developing, at the table – only a public-private partnership could shape vaccine markets to meet lower-income countries' needs

The strength of partnerships



- Enhanced partnerships anchored in the priorities of countries
- Joint delivery with other global health organisations
- Technical partnerships with regional partners
- Enhanced financial partnerships with regional organizations, multilateral development banks, and development finance institutions

Protecting our future

- Gavi will leverage market power to drive innovation and lower vaccine prices for 50% of its portfolio
- Lean operational costs: 97 cents of every \$1 goes to vaccines and delivery

- African Vaccine Market Accelerator to boost resilience and vaccine sovereignty
- Global health security focuses on outbreak prevention and stockpiling for diseases like Ebola, Cholera, Yellow Fever
- > 50% of Gavi vaccines to help countries tackle climate change and AMR




- Gavi's largest-ever portfolio: 24 life-saving vaccines for this generation of children to be the most protected ever
- > 100 million women and girls protected from cervical cancer, saving 1.5 million lives
- 50+ million children to receive the new malaria vaccine

Over the next 5 years countries will fund a record percentage of the costs of their vaccines, contributing >US\$ 4bn
 By 2030, 1 in 3 of the 73 Gavisupported lower-income countries will fully fund their own vaccine programs

- Gavi to enable 1.4 billion contacts between families and health services
- Gavi to strengthen health systems, reaching more women and zero-dose children

Challenges for Gavi programmes in F&C countries

Conflict, governance crises, sanctions, authoritarian regimes, natural disasters have a considerable impact on the success of Gavi's programmes. Trade offs required given limited resources and reduced partners and donors in country. Sustainability of EPI programme challenged.

Country Challenges Faced:

- Conflict, fragility, displaced pop. across a given country. Limited planning ability.
- ✓ Governance and EPI shifts quick and often
- ✓ Sanctions reduce immunisation funding
- ✓ Funds flow shifts due to coup, conflict, weak systems (with little notice and planning)
- √ Lack of transparency of data (eg Syria)
- ✓ Low-capacity in country teams pulled to support various non-EPI related tasks
- Lead to lengthy delays in the development of applications

Maximum flexibility required





Gavi gives tailored responses to fragility & conflict

Revised Fragility, Emergencies,
Displaced populations policy approved in June
2022

Segmented approach: Prioritization of countries affected by chronic fragility, acute emergencies and hosting large numbers of displaced populations

Development of Board-requested Fragility and Humanitarian Approach for 6.0 near finalisation

Constrained government capacity; non-state armed actors

Many competing priorities, governments under sanctions, areas under de facto control by non-state armed actors

F&H Approach: Tackling Immunisation Gaps in Fragile and

Contexts

Inadequate health system financing

Limited domestic funds which can be compounded by donor cuts, e.g., due to sanctions



Few supply chains with limited CCE, vulnerable to disruptions and limited reach

Low on-the-ground capacity of TA providers & health workers Limited Health workers, health leadership brain drain, variable capacity of TA providers




Hard-to-reach populations, insecurity, limited health infrastructure and high mistrust of authorities

Limited information systems and data availability

Unsystematic & uncoordinated data collection leading to limited data availability & quality




