


Mandate for negotiations with the European Parliament

<u>The SCA</u> took note of the information provided by the Presidency and by the Commission. The SCA also took note of the comments and questions from delegations.

10. Organisation of future work

<u>The Presidency</u> informed the SCA about the next SCA meeting on 2 June 2025 and the "Agriculture and Fisheries" Council meeting on 26 May 2025. Regarding that Council meeting,

- <u>Italy and Greece</u> requested a public item under "any other business" on "Separate funds between fisheries and agriculture policy";
- <u>Latvia</u> requested a public item under "any other business", on the meeting of the three Ministers of Agriculture of the Baltic states which took place in Riga on 11 April 2025;
- <u>The Commission</u> requested a public item under "any other business" on the AU-EU Agriculture Ministerial Conference, which will take place on 25 June 2025 in Rome;
- <u>The SCA</u> agreed that the three AOB items above would be taken in public session in accordance with Article 8(2) of the rules of procedure of the Council.
- <u>Luxembourg</u> informed the SCA about an item under "any other business", requested at Coreper, on "Simplification of the EUDR: difficulties in implementing the EUDR and the need for substantial simplification".

STATEMENT

Regulation amending the common market organisation (CMO)

Ad item 5:

Regulation as regards the strengthening of the position of farmers in the food supply chain

STATEMENT BY SLOVENIA

"Slovenia welcomes and supports the proposal to amend the CMO Regulation, as it represents a significant step towards strengthening the bargaining power of farmers and improving their position within the food supply chain.

However, we regret that the possibility of derogating from competition rules for non-recognised producer organisations and cooperatives has been excluded from the new draft of the Regulation.

For Slovenia, it is of key importance to address the legal status of cooperatives, which, in practice, already operate in a manner comparable to recognised producer organisations. Including the option for exemption would help clarify their position and enhance legal certainty in this regard."
