## b) PSC certificate

Admission to the discussion of this item will be granted only to those delegates for whom the GSC Safety and Security Directorate has a record of a PSC certificate or who can present a valid, original PSC certificate issued by their National Security Authority or by other competent national authorities.

<u>Only in case</u> a PSC certificate for the delegate concerned has not yet been transmitted to the GSC Security Clearances Office, a copy should be sent by the delegate's National Security Authority or other competent national authority or by the sending organisation's security officer to <a href="mailto:security.clearances@consilium.europa.eu">security.clearances@consilium.europa.eu</a> also by Wednesday, 28 May 2025 (noon Brussels time), indicating the reference of the meeting in the subject for quicker treatment.

It is in the interest of the participants to ensure that their PSC certificate has not expired.

Please note that PSC certificates sent by the delegates themselves will not be accepted.

During the discussion of the S-UE/EU-S item, all electronic devices must be left in the lockers outside the meeting room.
