The Council has requested from the European Commission a series of reports on the legal and economic consequences of the Spanish Government's request to add Basque, Catalan and Galician to Regulation No 1/1958 on the EU's language regime.

- I.- Today we received a response to the abovementioned request for access. No documents were attached.
- II.- The request for access was worded as follows:

We hereby REQUEST access to all reports received by the Council from the Commission and other bodies (including internal bodies) on the consequences of any kind of reform of Regulation No 1/1958, in particular the legal consequences or implications of such reform.

Please take note of the following, which appeared in Spanish on 14 May 2025:

'Ten Member States <u>and the EU's legal services</u> block Sánchez's latest attempt to make Catalan an official language.

Only Belgium and Portugal supported Spain's initiative in the preparatory technical committee of the General Affairs Council on 27 May.'

It can be inferred from the request that the legal services have issued an opinion on the matter, hence a report must exist which falls within the scope of the request.

The existence of legal reports is also apparent from subsequent press reports. By way of example:

El Mundo (28 May 2025): 'Italy and Germany lead the refusal to vote on the use of Catalan in the EU <u>after the legal services warned that</u> "the Treaties would have to be revised".

Seven countries were openly against deciding on the issue and at least three others requested "more information".'
