Subject:	Transfer of appropriations No DEC 10/2025 within Section III - Commission - of the general budget for 2025 Approval Approval of a letter

1. On 27 May 2025, the Commission submitted to the Council proposal for transfer of appropriations No DEC 10/2025 related to the mobilisation of the European Union Solidarity Fund¹, in accordance with Article 31(1) of the Financial Regulation².
2. As recorded in document 9491/25, the purpose of this proposal is to move an amount of EUR 270.07 million in commitment (c/a) and payment appropriations (p/a) from Item 30 04 01 01 (*European Solidarity Reserve*) to Items 16 02 01 01 (*Assistance to Member States in relation to events eligible under the European Union Solidarity Fund (EUSF)*) and 16 02 01 02 (*Assistance to countries negotiating for accession in relation to events eligible under the European Union Solidarity Fund (EUSF)*).

3. The aim of the proposal is to transfer a total amount of:
- EUR 224.22 million in c/a and p/a to award assistance to Austria, Poland, Czechia and Slovakia following the floods that took place in Central and Eastern Europe in September 2024. The current request also takes account of the advance of EUR 10.66 million paid to Austria;
 - EUR 45.86 million in c/a and p/a to award assistance to Moldova and Bosnia and Herzegovina following the floods that took place in September and October 2024.
4. The Budget Committee examined this proposal for a transfer at its meeting on 2 June 2025.
5. Following that examination, the Budget Committee agreed, by a qualified majority, to suggest that the Permanent Representatives Committee advise the Council to approve:
- the proposed transfer of appropriations, as set out in document 9491/25, and
 - the draft letter in the ANNEX to that effect.
