d) Detailed grounds for the decrease

In line with point 20 of the Inter-Institutional Agreement on the 2021-2027 Multiannual Financial Framework, amounts provided for in the budget for new fisheries agreements or for the renewal of fisheries agreements, which enter into force after 1 January of the financial year concerned, shall be included in reserve.

It is proposed to transfer an amount of EUR 825 000 in commitment and EUR 325 000 in payment appropriations from the reserve line to the main operational line, specifically to cover the financial obligations resulting from the Protocols implementing the Sustainable Fisheries Partnership Agreements (SFPA) to be concluded with the Democratic Republic of São Tomé and Príncipe (2025-2029).

d) Detailed grounds for the increase

The transfer of EUR 825 000 commitment appropriations and EUR 325 000 payment appropriations is necessary to meet the 2025 financial obligations resulting from the new Implementing Protocol to the Fisheries Partnership Agreement between the European Community and the Democratic Republic of São Tomé and Príncipe (2025-2029).

The previous five-year protocol with the Democratic Republic of São Tomé and Príncipe expired on 18 December 2024. Based on the Council Decision authorising the opening of negotiations, the Commission conducted negotiations, and a new protocol was initialled on 9 April 2025. The new Protocol covers a period of four years from the date of signature and its provisional application.

Following the Commission proposal COM(2025) 369 of 9 July 2025, the Council is expected to agree on the signing and provisional application of the Protocol in September 2025, with the signature planned by beginning of October. The first access payment (EUR 325 000) is due within 90 days following the entering into provisional application of the Protocol, while the first sectoral payment (EUR 500 000) is planned for 2026.
