Draft note to the Permanent Representatives Committee

- 1. By letter of 3 June 2025¹, the Secretary-General of the European Court of Auditors (ECA) informed the Council that the term of office of Ms Helga BERGER (Austria) as Member of the ECA will expire on 31 July 2026.
- 2. Article 286(1) and (2), first subparagraph, TFEU states that:
 - "1. The Members of the Court of Auditors shall be chosen from among persons who belong or have belonged in their respective States to external audit bodies or who are especially qualified for this office. Their independence must be beyond doubt.
 - 2. The Members of the Court of Auditors shall be appointed for a term of six years. The Council, after consulting the European Parliament, shall adopt the list of Members drawn up in accordance with the proposals made by each Member State. The term of office of the Members of the Court of Auditors shall be renewable".
- In order to ensure the continuity of ECA's work, the new Member of the ECA should be 3. appointed by the end of July 2026.
- 4. The Member State concerned should therefore send its proposal for a new Member to the General Secretariat of the Council by 31 March 2026. To that effect, the General Secretariat of the Council will send a letter to the Member State concerned.
- 5. It is therefore suggested that the <u>Permanent Representatives Committee</u> approve the wording of the reply letter to the Secretary-General of the ECA, as set out in the Annex to this note, in accordance with Article 19(7)(k) of the Council's Rules of Procedure.

In reply to your letter of 3 June 2025 concerning one Member of the European Court of Auditors (ECA) whose term of office will expire on 31 July 2026, I inform you that the General Secretariat of the Council will invite the Member State concerned to put forward its proposal for Member of the ECA by 31 March 2026.

In order to ensure the continuity of the ECA's work, the Council Decision appointing the Member of the ECA should be adopted by the end of July 2026. To that end, the procedure for the appointment of the Member should start sufficiently early to allow for the timely consultation of the European Parliament.
