In accordance with the procedure for the appointment of members and alternate members to the European Committee of the Regions for the period from 26 January 2025 to 25 January 2030, I would like to inform you about the change in the composition of the Croatian representatives that has taken place following the 2025 local elections in the Republic of Croatia.

Therefore, in the Croatian delegation to the European Committee of the Regions, for the remainder of the current term and in accordance with the new Croatian Government Decision from 21 August 2025 (Class: 022-03/25-04/366, Ref.No.: 50301-15/28-25-2), the following national representative has been nominated for the position of member:

Mr Nikola DOBROSLAVIĆ

- Type of national mandate: **Member of a Regional Assembly** holding an electoral mandate: *član Županijske skupštine Dubrovačko-neretvanske županije* (EN: *Member of the Regional Assembly of Dubrovnik-Neretva county*);
- Duration of the national mandate: until local elections in May 2030.

Following this notification, we would kindly ask the General Secretariat of the Council to take the necessary steps with a view to adopting the relevant Council decision appointing the new member from Croatia to the European Committee of the Regions.
