THE COUNCIL OF THE EUROPEAN UNION,

Having regard to the Treaty on the Functioning of the European Union, and in particular Article 16(2) and Article 87(2), point (a), in conjunction with Article 218(6), second subparagraph, point (a), thereof,

Having regard to the proposal from the European Commission,

Having regard to the consent of the European Parliament¹,

Whereas:

- In accordance with Council Decision (EU) 2025/...²⁺, the Agreement between the (1) European Union and the Kingdom of Norway on the transfer of passenger name record (PNR) data to prevent, detect, investigate and prosecute terrorist offences and serious crime (the 'Agreement') was signed on ... ++, subject to its conclusion at a later date.
- (2) The Agreement provides for the transfer of PNR data by air carriers from the Union to the Kingdom of Norway ('Norway') in full respect of the rights provided in the Charter of Fundamental Rights of the European Union, in particular the right to respect for private and family life and the right to the protection of personal data, recognised in Articles 7 and 8, respectively, thereof. In particular, the Agreement includes appropriate safeguards for the protection of personal data transferred under it.
- (3) The Agreement fosters police and judicial cooperation between the competent authorities of Norway and those of the Member States as well as Europol and Eurojust, with the aim to enhance their capabilities to strengthen the external borders of the Union and of Norway, as well as to effectively ensure internal security in the absence of internal border controls within the Schengen area.

- (4) In accordance with Article 3 of Protocol No 21 on the position of the United Kingdom and Ireland in respect of the area of freedom, security and justice, annexed to the Treaty on European Union (TEU) and to the Treaty on the Functioning of the European Union (TFEU), Ireland has notified, by letter of 29 July 2025, its wish to take part in the adoption and application of this Decision.
- In accordance with Articles 1 and 2 of Protocol No 22 on the position of Denmark, (5) annexed to the TEU and to the TFEU, Denmark is not taking part in the adoption of this Decision and is not bound by it or subject to its application.
- (6)The European Data Protection Supervisor was consulted in accordance with Article 42(1) of Regulation (EU) 2018/1725 of the European Parliament and of the Council³ and delivered its Opinion 16/2025 on 24 July 2025⁴.
- (7) The Agreement should be approved on behalf of the European Union,
