COUNCIL DECISION appointing a member, proposed by the Republic of Croatia, of the Committee of the Regions Subject:

THE COUNCIL OF THE EUROPEAN UNION,

Having regard to the Treaty on the Functioning of the European Union, and in particular Article 305 thereof,

Having regard to Council Decision (EU) 2019/852 of 21 May 2019 determining the composition of the Committee of the Regions¹,

Having regard to the proposal of the Croatian Government,

Whereas:

- Pursuant to Article 300(3) of the Treaty, the Committee of the Regions is to consist of (1) representatives of regional and local bodies who either hold a regional or local authority electoral mandate or are politically accountable to an elected assembly.
- On 10 December 2024, the Council adopted Decision (EU) 2025/71², appointing the (2) members and alternate members of the Committee of the Regions for the period from 26 January 2025 to 25 January 2030.
- (3) A member's seat on the Committee of the Regions has become vacant following the end of the national mandate on the basis of which Mr Nikola DOBROSLAVIĆ was proposed for appointment.
- (4) The Croatian Government has proposed, on the basis of a different national mandate, Mr Nikola DOBROSLAVIĆ, representative of a regional body who holds a regional authority electoral mandate, *Član Županijske skupštine Dubrovačko-neretvanske županije* (Member of the Regional Assembly of Dubrovnik-Neretva county), as a member of the Committee of the Regions for the remainder of the current term of office, which runs until 25 January 2030.

Article 1

Mr Nikola DOBROSLAVIĆ, representative of a regional body who holds a regional authority electoral mandate, *član Županijske skupštine Dubrovačko-neretvanske županije* (Member of the Regional Assembly of Dubrovnik-Neretva county) (change of mandate), is hereby appointed as a member of the Committee of the Regions for the remainder of the current term of office, which runs until 25 January 2030.

Article 2

This Decision shall enter into force on the date of its adoption.
