1. On page 24, in Article 9(2)

for:

 - (v) contribute to the deployment of other technologies accelerating the decarbonisation of the economy.’,

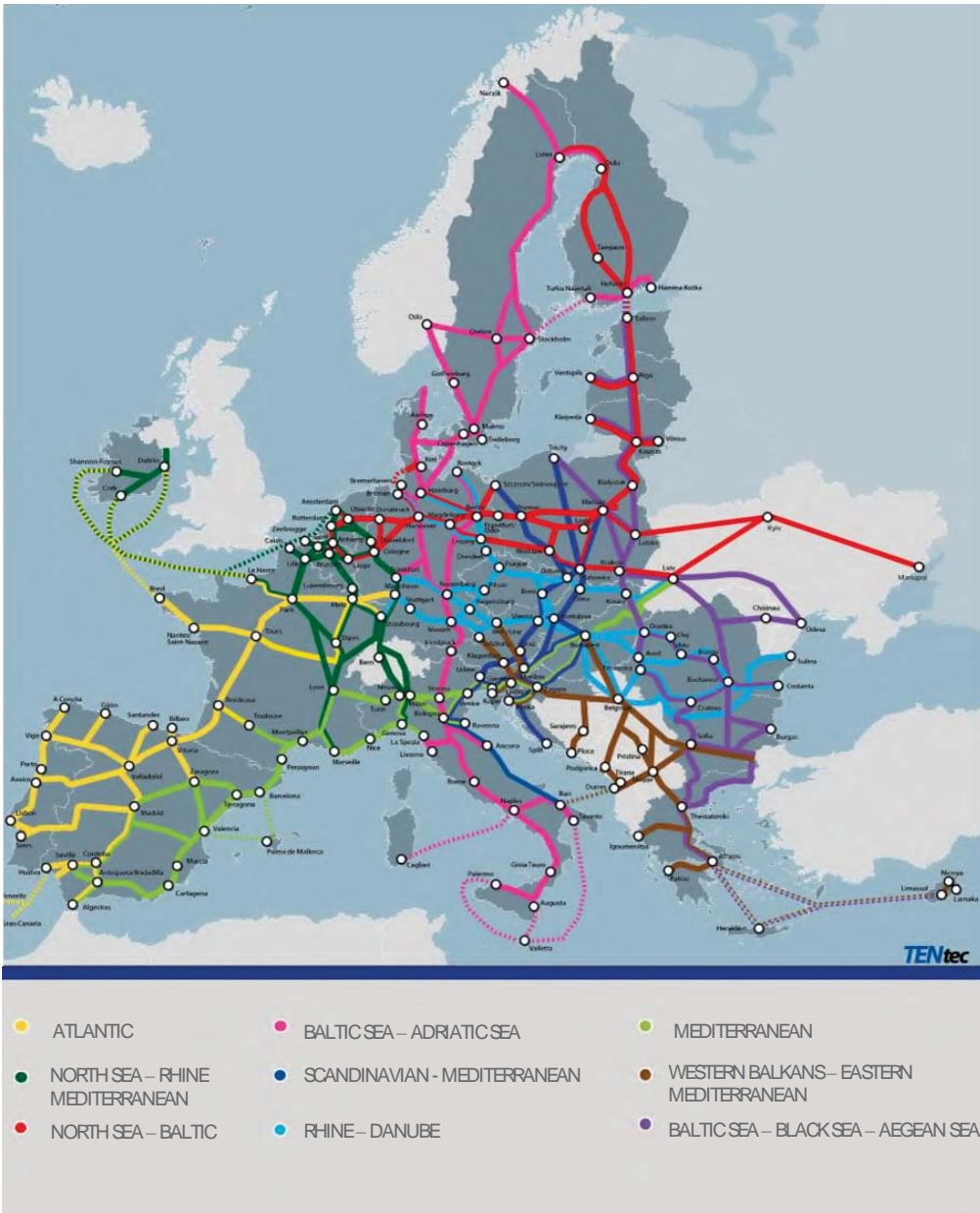

Map Finder Chart for European Transport Corridors

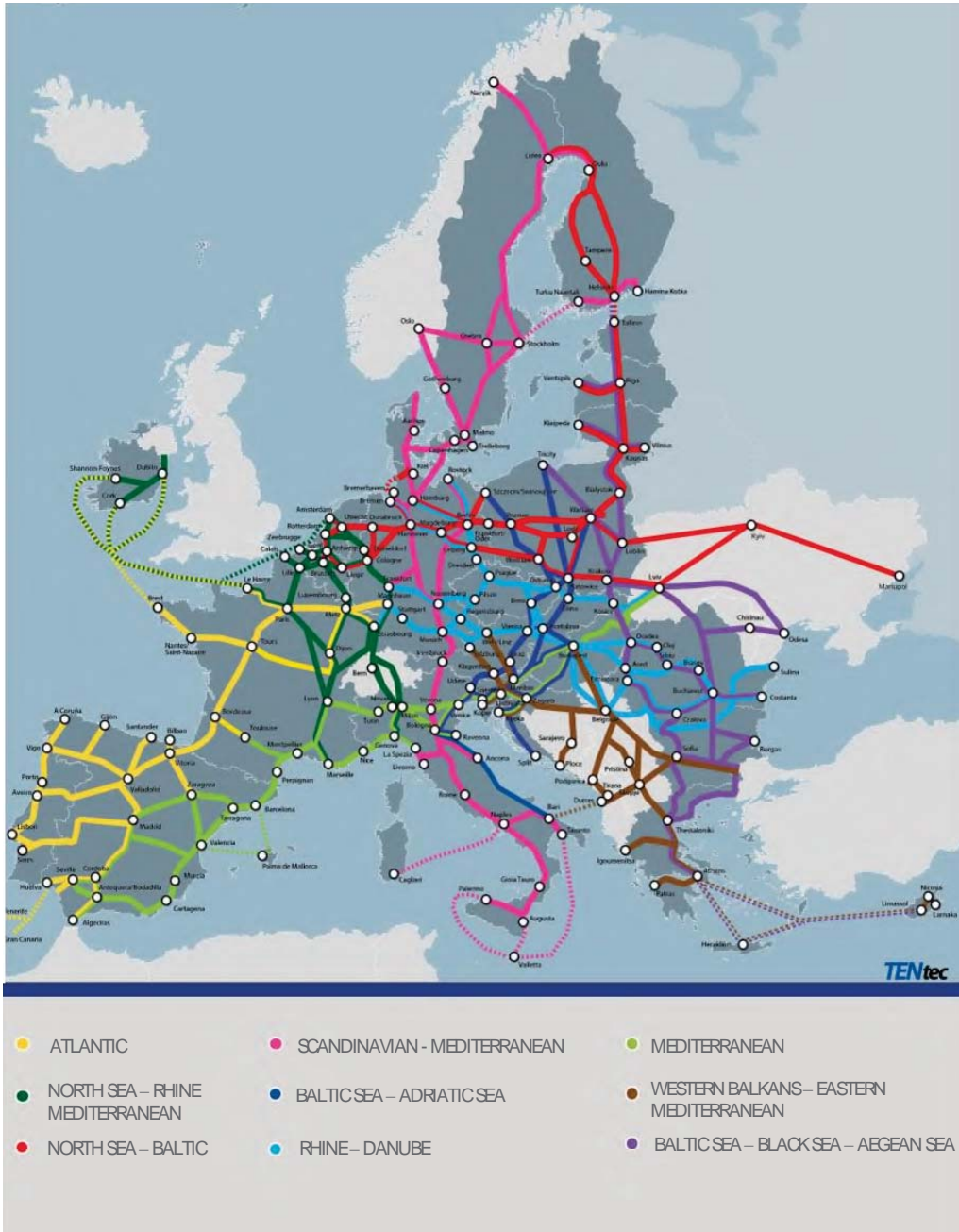
