# INFORMATION FROM THE PRESIDENCY ON CURRENT LEGISLATIVE PROPOSALS

#### **HOME AFFAIRS**

## Legislative proposals in the area of internal security

Regulation on enhancing police cooperation in the fight against migrant smuggling and trafficking in human beings

On 28 November 2023, the Commission proposed a legislative package to counter migrant smuggling. This comprises a directive on criminal law and a Regulation, which enhances police cooperation, as well as Europol's support in the area of migrant smuggling and trafficking in human beings. The proposal for a Regulation was discussed at several Law Enforcement Working Party - Police meetings.

On 25 September 2025, the co-legislators reached a provisional agreement at a trilogue. The compromise text was endorsed by Coreper on 8 October. The vote of the EP on the text in first reading is expected to take place in November's plenary.

### Regulation to prevent and combat child sexual abuse

On 11 May 2022, the Commission adopted a legislative proposal aimed at preventing and combating child sexual abuse (CSA) online. The proposal is being examined at the Law Enforcement Working Party – Police. The last Presidency compromise text adds safeguards to protect cyber security and to ensure proportionality and the respect for fundamental rights, while preserving the objectives and the effectiveness of the proposed Regulation. More work is still needed at technical level to reach an agreement for a mandate for negotiations with the European Parliament.

In the European Parliament, the Committee on Civil Liberties, Justice and Home Affairs (LIBE) adopted the rapporteur's report by Mr Javier Zarzalejos (EPP, ES) on 14 November 2023.

#### Legislative proposals in the area of MFF (JHA) financial instruments

Proposal for a Regulation of the European Parliament and of the Council establishing the Union support for asylum, migration and integration for the period from 2028 to 2034

On 16 July 2025, the Commission presented its proposal for a Regulation of the European Parliament and of the Council establishing the Union support for asylum, migration and integration for the period from 2028 to 2034. The proposal was presented at the Ad hoc Working Party on JHA Financial Instruments on 2 September 2025 and the article-by-article examination started on 3 October 2025. The European Parliament has not yet appointed a rapporteur on this file.

Proposal for a Regulation of the European Parliament and of the Council establishing the Union support for the Schengen area, for European integrated border management and for the common policy on visas for the period from 2028 to 2034

On 16 July 2025, the Commission presented its proposal for a Regulation establishing the Union support for the Schengen area, for European integrated border management and for the common policy on visas for the period from 2028 to 2034. The proposal was presented at the Ad hoc Working Party on JHA Financial Instruments on 2 September 2025 and the article-by-article examination started on 3 October 2025. The European Parliament has not yet appointed a rapporteur on this file.

Proposal for a Regulation of the European Parliament and of the Council establishing the Union support for internal security for the period from 2028 to 2034

On 16 July 2025, the Commission presented its proposal for a Regulation of the European Parliament and of the Council establishing the Union support for internal security for the period from 2028 to 2034. The proposal was presented at the Ad hoc Working Party on JHA Financial Instruments on 2 September 2025 and the article-by-article examination started on 3 October 2025. The European Parliament has not yet appointed a rapporteur on this file.

#### Legislative proposals in the area of asylum, migration, borders and visa

## Regulation on situations of instrumentalisation in the field of migration and asylum

On 14 December 2021, the Commission presented its proposal for a Regulation addressing situations of instrumentalisation in the field of migration and asylum. The proposal was discussed in the Council's Asylum Working Party, as well as at JHA Counsellor level in 2022. Coreper did not approve a partial general approach on 7 December 2022. Further discussions on the proposal took place at the informal Strategic Committee on Immigration, Frontiers and Asylum (SCIFA) on 20 April 2023.

In the European Parliament, rapporteur Mr Patryk Jaki (ECR, PL) presented his draft report to the LIBE Committee on 11 September 2023, but the LIBE Committee did not adopt a report. In the new Parliament Mr Jaki is no longer a member of the LIBE Committee.

Meanwhile, the scope of the Crisis and *force majeure* regulation, which was adopted on 14 May 2024, includes situations of instrumentalisation.

In its Work Programme for 2025 the Commission announced its intention to withdraw this proposal.

## Decision on provisional emergency measures for the benefit of Latvia, Lithuania and Poland

The Commission presented its proposal for a Council Decision on interim emergency measures for Latvia, Lithuania and Poland on 1 December 2021. The Council's Asylum Working Group began examining the proposal in January 2022. The text was discussed in Coreper in February 2022, but the Member States did not reach an agreement. Negotiations have not resumed since.

In the European Parliament, Ms Cornelia Ernst (GUE/NGL, DE) was appointed rapporteur for the file and LIBE is the lead committee. In the new Parliament Ms Ernst is no longer a member of the LIBE Committee.

In its Work Programme for 2025 the Commission announced its intention to withdraw this proposal.

## Regulation amending Regulation (EU) 2024/1348 as regards the establishment of a list of safe countries of origin at Union level

On 16 April 2025, the European Commission tabled a proposal for a regulation amending the Asylum Procedure Regulation (APR) as regards the establishment of a list of safe countries of origin at Union level. The proposal was discussed at the Asylum Working Party on 24 April, 16 May, 10 June, 11 July and 8 September 2025. It is now being negotiated at the level of the JHA counsellors (the last meeting took place on 3 October 2025) with the overall objective to reach a general approach by the end of the Danish Presidency. The European Parliament appointed Alessandro Ciriani (ECR, IT) as Rapporteur on this file.

## Regulation amending Regulation (EU) 2024/1348 as regards the application of the 'safe third country' concept

On 20 May 2025, the Commission tabled a proposal for a regulation amending the Asylum Procedure Regulation as regards the application of the 'safe third country' concept. The proposal has been discussed at the Asylum Working Party on 10 June, 11 July and 8 September 2025. It is now being negotiated at the level of the JHA counsellors (the last meeting took place on 3 October) with the overall objective to reach a general approach by the end of the Danish Presidency. The European Parliament appointed Lena Düpont (EPP, DE) as Rapporteur on this file.

## **Long-Term Residents Directive**

On 27 April 2022, the Commission presented a recast of the Directive concerning the status of third-country nationals who are long-term residents (known as the LTR Directive). The current Long-Term Residents Directive dates back to 2003 (Council Directive 2003/109/EC of 25 November 2003).

After several discussions in the Council's Working Party on Integration, Migration and Expulsion – Admission (IMEX Admission) and by the JHA Counsellors (IMEX – Admission), Coreper adopted a negotiating mandate on 23 November 2023. Two political trilogues took place (30 November 2023 and 16 January 2024). In early March 2024, the interinstitutional negotiations were halted.

In the European Parliament, the LIBE Committee voted for the report by rapporteur Mr Damian Boeselager (Greens/EFA, DE) on 28 March 2023, a result confirmed by the Plenary on 20 April 2023. In the new Parliament, Ms Anna Strolenberg (Greens/EFA, NL) has been appointed as the new Rapporteur for this file. At the meeting on 18 March 2025 the JHA Counsellors did not support the resumption of interinstitutional negotiations with the European Parliament given the significantly different positions between the co-legislators and the lack of flexibility from the European Parliament.

## Regulation establishing an EU Talent Pool

The proposal for a Regulation establishing an EU Talent Pool was presented by the Commission on 15 November 2023 as part of the Skills and Talent Mobility package. Under the Spanish and Belgian Presidencies, the Working Party on Integration, Migration and Expulsion (Admission) discussed the proposal from December 2023 until May 2024. JHA Counsellors (IMEX Admission) discussed the proposal on 30 May 2024 and expressed broad support to the Presidency compromise text. On 13 June 2024, the Council reached a General Approach.

In the European Parliament, Ms Abir Al-Sahlani (Renew, SE) was re-appointed as rapporteur in 2024 and the LIBE Committee is the lead committee. The European Parliament adopted its mandate on 3 April 2025, and the interinstitutional negotiations began on 7 April 2025. Several technical meetings were held between April and July. The second political trilogue was held on 15 July. After further technical meetings in September, the third political trilogue was held on 24 September where all the remaining political issues were discussed. The next, and potentially the last, trilogue is expected to take place in November.

## Regulation amending Regulation (EU) 2018/1806 as regards the revision of the mechanism to suspend the visa exemption

On 18 October 2023, the Commission presented a proposal aimed at amending Regulation (EU) 2018/1806 as regards the suspension mechanism. Following interinstitutional negotiations started on 1 April 2025, a political agreement was reached by the two co-legislators on 17 June 2025.

After the vote by the European Parliament on the first reading, expected at the first plenary session of October, the Council will adopt the legal act on 17 November 2025 and the Regulation will then be signed on 26 November 2025 in Strasbourg. It will enter into force on the twentieth day following that of its publication in the Official Journal of the European Union.

Regulation establishing an application for the electronic submission of travel data ("EU Digital Travel application") and amending Regulations (EU) 2016/399 and (EU) 2018/1726 of the European Parliament and of the Council and Council Regulation (EC) No 2252/2004, as regards the use of digital travel credentials

On 8 October 2024, the Commission submitted its proposal for a Regulation establishing an application for the electronic submission of travel data ("EU Digital Travel application") and amending Regulations (EU) 2016/399 and (EU) 2018/1726 of the European Parliament and of the Council and Council Regulation (EC) No 2252/2004, as regards the use of digital travel credentials.

The objective is establishing a uniform standard for digital travel credentials and a common EU application (EU Digital Travel application) for using them.

The proposal was presented at the meeting of the Frontiers Working Party on 22 November 2024. On 4 February, 19 March, 16 April and 15 May 2025, the proposal was again discussed by the Frontiers Working Party. The proposal was presented to the LIBE Committee in the European Parliament on February 20<sup>th</sup>. Mr Juan Fernando Lopez Aguilar (S&D, ES) was appointed rapporteur.

The Presidency was working on compromise proposals for parts of the text which were presented at the Frontiers Working Party on 5 June 2025. Subsequent compromise proposals were discussed by the Working Party on 1 July, 1 September and 7 October 2025 and by the JHA Counsellors on 23 September 2025. A new compromise proposal is scheduled for discussion by the JHA Counsellors 16 October 2025.

## Council Regulation on the issuance of and technical standards for digital travel credentials based on identity cards

The proposal for a Regulation on the issuance of and technical standards for digital travel credentials) based on identity cards was submitted by the Commission on 8 October 2024. The proposal is closely linked to the aforementioned *Regulation establishing an application for the electronic submission of travel data as regards the use of digital travel credentials* but must be treated separately as different legal bases apply.

The Commission presented the proposal to the meeting of the Frontiers Working Party on 22 November 2024. Initial efforts are focused on progressing with the aforementioned Regulation. On 21 October 2024, the Council decided to consult the EP on the proposal and asked the EP to submit is opinion as soon as possible.

The proposal was presented to the LIBE Committee in the European Parliament on 20 February 2025. Ms Marieke Ehlers (PfE, NL) was appointed rapporteur.

Regulation on measures against transport operators that facilitate or engage in trafficking in persons or smuggling of migrants in relation to illegal entry into the territory of the European Union

On 23 November 2021, the Commission presented a proposal for a Regulation on measures against transport operators that facilitate or engage in trafficking in persons or smuggling of migrants in relation to illegal entry into the territory of the European Union. The proposal is based on Article 91 and Article 100(2) of the Treaty on the Functioning of the European Union.

The proposal was initially examined by the Working Party of Foreign Relations Counsellors as lead preparatory body. On 9 January 2025, the Polish Presidency announced in Coreper that the file would be reattributed to the Justice and Home Affairs Counsellors, reinforced by other experts where appropriate. Six JHA Counsellors meetings took place from January to June 2025 to examine the proposal and discuss three versions of a Presidency compromise text. On 12 May 2025, Coreper held an exchange of views on the state of play and provided guidance for further work on the proposal. On 27 June 2025, a progress report was presented to Coreper by the Polish Presidency.

The European Parliament has not adopted a negotiating mandate during the last Parliament term. Under the new Parliament, the proposal has been referred to the Joint Committee procedure on 13 November 2024, with the LIBE and TRAN committees to present a single report. Each committee appointed a rapporteur: Mr Tomas Tobé (EPP, SE) for LIBE and Mr Sérgio Gonçalves (S&D, PT) for TRAN.

#### **JUSTICE**

## Regulation on the law applicable to the third-party effects of assignments of claims

The proposal for a Regulation on the law applicable to the third-party effects of assignments of claims was submitted by the Commission on 12 March 2018.

The objective of the proposal was to increase cross-border transactions in claims and, thereby, facilitate access to finance by ensuring greater legal certainty for investors when dealing with cross-border transactions of claims.

The proposal was dealt with by the Working Party on Civil Law Matters.

The European Parliament adopted its position at first reading on 13 February 2019.

The Council reached a general approach on 7 June 2021.

In its Work Programme for 2025 the Commission announced its intention to withdraw this proposal.

On 6 October 2025, the proposal has been withdrawn by the Commission (Official Journal OJ C, C/2025/5423, 6.10.2025).

### **AI Liability Directive**

On 28 September 2022, the Commission presented a proposal for a Directive on adapting non-contractual civil liability rules to artificial intelligence (AI Liability Directive).

The objective of the proposal was a minimum harmonisation of selected aspects of national rules on non-contractual civil liability for AI in order to make it easier for victims of AI-related damage to receive compensation.

The proposal was dealt with in the Working Party on Civil Law Matters.

In its Work Programme for 2025 the Commission announced its intention to withdraw this proposal.

On 6 October 2025, the proposal has been withdrawn by the Commission (Official Journal OJ C, C/2025/5423, 6.10.2025).

## Regulation on the cross-border recognition of parenthood

On 7 December 2022, the Commission submitted a proposal for a Regulation on jurisdiction, applicable law, recognition of decisions and acceptance of authentic instruments in matters of parenthood and on the creation of a European Certificate of Parenthood.

The objective of the proposal is to facilitate the cross-border recognition of parenthood within the EU.

The proposal is being dealt with by the Working Party on Civil Law Matters. The Council held an exchange of view on some aspects of the proposal during its meeting of 14 June 2024. Discussions are continuing in the Working Party.

## Directive harmonising certain aspects of insolvency law

On 7 December 2022, the Commission submitted a proposal for a Directive harmonising certain aspects of insolvency law. The objective of the proposal is to harmonise targeted aspects of Member States' insolvency laws to improve the recovery of assets from the liquidated insolvency estate, ensure their fair and predictable distribution and improve the overall efficiency of insolvency proceedings. This should facilitate cross-border investments within the EU. The proposal is being dealt with in the Working Party on Civil Law Matters.

The conclusions of the European Council of 17-18 April 2024 called for an advancement of the work without delay on measures important for the further integration of the Capital Markets Union, including the harmonisation of insolvency regimes. Furthermore, according to conclusions of 20 March 2025, the European Council expects the co-legislators to quickly agree on all pending proposals from the 2020 Action Plan on the Capital Markets Union, including on insolvency. The Council reached a general approach on the proposal during its meeting of 12 and 13June 2025.

In the European Parliament, the lead Committee is JURI. The rapporteur is Emil Radev (EPP). The JURI Committee adopted the draft report on 24 June 2025. The Committee decision to enter into interinstitutional negotiations was confirmed by the plenary on 9 July 2025.

A first trilogue was held on 9 July 2025. A second and possibly final trilogue is planned in November.

## **Directive on combating corruption**

The Commission submitted its proposal for a Directive on combating corruption on 3 May 2023. The objective of the proposal is to update and harmonise EU rules on the definitions of and penalties for corruption offences, in both the public and private sectors, and includes preventive measures. The proposal is dealt with in the Working Party on Judicial Cooperation in Criminal Matters (COPEN).

The Council reached a general approach on this proposal during its meeting of 14 June 2024.

In the European Parliament, the lead Committee is LIBE. The rapporteur is Raquel Garcia Hermida-Van der Walle (Renew). The LIBE Committee adopted the draft report on 31 January 2024. The Committee decision to enter into interinstitutional negotiations was confirmed by the plenary on 27 February 2024.

Trilogues took place on 28 January, 26 March, 6 May and 17 June 2025. Negotiations with the Parliament are ongoing to solve the remaining issues and a fifth political trilogue is scheduled to take place in November.

## Regulation on protection of adults

On 31 May 2023, the Commission submitted a proposal for a Regulation on jurisdiction, applicable law, recognition and enforcement of measures and cooperation in matters relating to the protection of adults.

The proposal establishes provisions concerning adults who, by reason of an impairment or insufficiency of their personal faculties, are not in a position to protect their own interests. The main objective of the proposal is to enhance the protection of their rights - including access to justice, individual autonomy, the right to property and to free movement as well as to improve the effectiveness of judicial and administrative proceedings, thereby strengthening legal certainty and predictability. The proposal was submitted together with a draft Council decision authorising Member States to become or remain parties, in the interest of the European Union, to the Convention of 13 January 2000 on the International Protection of Adults.

The proposal is dealt with in the Working Party on Civil Law Matters. The Council reached a partial general approach on Chapters I to V (scope, jurisdiction, applicable law, recognition and enforcement, authentic instruments) at its meeting of 12 and 13 June 2025. Discussions are continuing in the Working Party on the remaining parts of the proposal in order to reach a mandate for negotiations with the Parliament as soon as possible.

In the European Parliament, the lead Committee is JURI. The rapporteur is Jana Toom (RENEW). The JURI Committee adopted the draft report on 24 June 2025. The Committee decision to enter into interinstitutional negotiations was confirmed by the plenary on 9 July 2025.

### Regulation on enforcement procedures of the General Data Protection Regulation

On 4 July 2023, the Commission submitted a proposal for a Regulation laying down additional procedural rules relating to the enforcement of Regulation (EU) 2016/679. The objective of the proposal is to clarify and complement existing procedural rules under the GDPR applicable to cooperation between data protection authorities, in order to streamline and speed up enforcement proceedings in cross-border cases. In particular, the proposal provides for the targeted harmonisation of rules in relation to the submission and handling of complaints, the role of the complainant in the procedure, the procedural steps and tools for Data Protection Authorities to reach consensus at an early stage, and the facilitation of dispute resolution proceedings in the European Data Protection Board (EDPB).

The proposal is being dealt with in the Working Party on Data Protection.

The Council reached a general approach on this proposal on 14 June 2024.

In the European Parliament, the lead Committee is LIBE. Sergey Lagodinsky (Greens/EFA) was appointed as rapporteur for the 9th parliamentary term. The LIBE Committee adopted the draft report on 20 February 2024. The European Parliament adopted its position at first reading on 10 April 2024. Markéta Gregorová (Greens/EFA) was appointed as a rapporteur on 20 September 2024.

A provisional agreement was reached at the fourth trilogue of 16 June 2025. Coreper confirmed agreement on the final compromise text on 27 June 2025. Revision of the text by lawyer-linguists has been finalised, with a view to the Regulation's adoption by the co-legislators.

## Directive amending Directive 2012/29/EU on the rights of victims

On 12 July 2023, the Commission submitted its proposal to amend Directive 2012/29/EU establishing minimum standards on the rights, support and protection of victims of crime. The objective of the proposal is to address specific shortcomings identified in the existing framework, which require targeted improvements in relation to the exercise of victim's rights, especially as regards: the right to information; protection and specialist support, victims' participation in criminal proceedings and victims' access to compensation.

The proposal is dealt within the Working Party on Judicial Cooperation in Criminal Matters (COPEN).

The Council held an exchange of views on the proposal during its meeting of 4 December 2023 and reached a general approach on 14 June 2024.

In the European Parliament, the lead Committees are LIBE and FEMM. The Committees adopted a draft report on the file on 14 March 2024. The decision to enter interinstitutional negotiations with the Council was confirmed in plenary, on 11 April 2024. The rapporteurs are Javier Zarzalejos (EPP) and Lucia Yar (Renew).

Trilogues took place on 2 December 2024, 5 February 2025, 9 April and 25 June 2025. Negotiations with the Parliament are ongoing to solve the remaining issues.

## Directive on minimum rules to prevent migrant smuggling

On 28 November 2023, the Commission submitted a proposal for a Directive laying down minimum rules to prevent and counter the facilitation of unauthorised entry, transit and stay in the Union, and replacing Council Directive 2002/90/EC and Council Framework Decision 2002/946 JHA. The objective of the proposal is to clearly define and effectively sanction the offence of migrant smuggling, in line with the UN Protocol against the Smuggling of Migrants by Land, Sea and Air.

The proposal is being dealt with in the Working Party on Judicial Cooperation in Criminal Matters (COPEN).

The Council held an exchange of views on some aspects of the proposal during its meeting of 5 March 2024 and reached a general approach on 13 December 2024.

In the European Parliament, the lead Committee is LIBE. The rapporteur is Birgit Sippel (S&D).

## Directive on child sexual abuse and exploitation

On 6 February 2024, the Commission submitted a proposal for a Directive on combating the sexual abuse and sexual exploitation of children and child sexual abuse material and replacing Council Framework Decision 2004/68/JHA (recast). The revised rules aim to update the legal framework in the light of the technological developments and to ensure more effective investigation and prosecution and strengthen both prevention of child sexual abuse and sexual exploitation and assistance to victims.

The proposal is dealt with in the Working Party on Judicial Cooperation in Criminal Matters (COPEN).

The Council held an exchange of views on some aspects of the proposal during its meeting of 14 June 2024 and reached a general approach on 13 December 2024.

In the European Parliament, the lead Committee is LIBE. The rapporteur is Jeroen Lenaers (EPP). The LIBE Committee adopted the draft report on 13 May. The Committee decision to enter into interinstitutional negotiations was confirmed by the plenary on 17 June.

A first trilogue was held on 23 June 2025. The next trilogue is scheduled on 6 November.

## Regulation amending article 80(9) of Eurojust Regulation (EU) 2018/1727

On 2 April 2025, the Commission submitted a proposal for a Regulation amending Regulation (EU) 2018/1727 as regards the extension of the timeframe for the establishment of the Eurojust case management system.

The proposal is dealt with in the Working Party on Judicial Cooperation in Criminal Matters (COPEN). On 23 July 2025, Coreper reached an agreement on the text, without making any changes to the proposal of the Commission.

In the European Parliament, the lead Committee is LIBE. The rapporteur is Javier Zarzalejos (EPP). The Parliament adopted its position in first reading on 10 September 2025. The Regulation was adopted by the Council on 29 September 2025. The Regulation is due to be signed on 8 October 2025 and will be published in the Official Journal soon afterwards.

Regulation establishing the Justice programme for the period 2028-2034 and repealing Regulation (EU) 2021/693

On 3 September 2025, the Commission submitted a proposal for a Regulation establishing the Justice programme for the period 2028-2034 and repealing Regulation (EU) 2021/693. The proposal is dealt with in the Ad Hoc Working Party on JHA Financial Instruments. It was first presented at the Working Party on 3 October 2025.
