Subject:	Transfer of appropriations No DEC 16/2025 within Section III - Commission - of the general budget for 2025

1. On 3 October 2025, the Commission submitted to the Council proposal for transfer of appropriations No DEC 16/2025 related to the mobilisation of the European Union Solidarity Fund¹, in accordance with Article 31(1) of the Financial Regulation².
2. As recorded in document 13519/25, the purpose of this proposal is to move an amount of EUR 927.93 million in commitment (c/a) and payment appropriations (p/a) from Item 30 04 01 01 (*European Solidarity Reserve*) to Item 16 02 01 01 (*Assistance to Member States in relation to events eligible under the European Union Solidarity Fund (EUSF)*).

3. The aim of the proposal is to cover the balance payment to Spain (EUR 846.15 million) and France (EUR 81.77 million) following their applications for financial contributions from the EUSF, as a result of the DANA floods in 2024, and the cyclones that hit Mayotte in 2024 and Réunion in 2025, respectively. The current request also takes account of the advance payments already paid to Spain (EUR 100 million) and to France (EUR 29.09 million).
 4. The Budget Committee examined this proposal for a transfer at its meeting on 9 October 2025.
 5. Following that examination, the Budget Committee agreed, by a qualified majority, to suggest that the Permanent Representatives Committee advise the Council to approve:
 - the proposed transfer of appropriations, as set out in document 13519/25, and
 - the draft letter in the ANNEX to that effect.
