- Frame the free access to the (legal) content of harmonised standards.
- Preserve the financial model of CEN and CENELEC and our national standardization bodies.
- Invest and allocate EU-funds to improve and implement digital tools (e.g. digital platforms).



A Modern Regulation Based on Strong Principles







- Reinforce the national delegation principle - based on openness, inclusiveness, transparency and consensus.
- Clarify copyright and legal certainty for harmonised standards.
- Promote the use of agile deliverables that could offer Presumption of Conformity to meet urgent legislative needs in fastmoving sectors (e.g. European Agile Specification).

Reinforce Europe's Global Leadership




Standards are Europe's voice in the world

Speed & Agility





Europe must match the speed of innovation, and we have a range of tools to deliver.

- Promote flexible tools such as Technical Specifications, Workshop Agreements, and European Agile Specifications to meet urgent legislative needs.
- Leverage the Public Private Partnership and agree together on an efficient citation process (SReq pre-consultations, defined timelines for HAS assessments, etc)

Trust & Coherence



Global cooperation, whilst preserving our European integrity.

- Opening the framework to other organizations (SDOs) or consortia should be contingent on their commitment to inclusiveness, transparency, and openness - preserve the integrity of our system.
- Be mindful of the strength of the ESOs system and the strain a fragmented SDOs approach would put on SMEs and consumers representation.

CEN and CENELEC Technical Boards agreed to:

- Identify and propose innovative ways of working, including the use of digital tools, to support agile drafting and collaboration (e.g. OSD).
- Analyse practices of SDOs and consortia relevant to agile and 'fast-track' deliverables to identify ways of collaboration.
