Subject: Transfer of appropriations No DEC 1/2025 within Section VII - Committee of the Regions - of the general budget for 2025

1. On 23 October 2025, the Committee of the Regions (CoR) submitted to the Council proposal for transfer of appropriations No DEC 1/2025, in accordance with Article 31 of the Financial Regulation¹.
2. The purpose of this proposal is to transfer from Item 1 2 0 0 (*Remuneration and allowances*) a total amount of EUR 661 109 to Items:
 - 2 1 0 0 (*Purchase, servicing and maintenance of equipment and software, and related work*) (EUR 14 889),
 - 2 1 0 2 (*Outside assistance for the operation, development and maintenance of software systems*) (EUR 221 220),
 - 2 6 0 1 (*Permanent dialogue mechanism*) (EUR 205 000) and
 - 2 6 0 3 (*EU Councillors*) (EUR 220 000).

3. These reinforcements are needed in order to finance five IT related joint CoR-EESC projects and five communication related projects.
 4. The Budget Committee examined this proposal for a transfer at its meeting on 29 October 2025.
 5. Following the examination, the Budget Committee agreed, by a qualified majority, to suggest that the Permanent Representatives Committee advise the Council to approve:
 - the proposed transfer of appropriations;
 - the draft letter in the ANNEX to that effect.
