Subject:	Transfer of appropriations No DEC 18/2025 within Section III - Commission - of the general budget for 2025
	• <i>Approval</i> • <i>Approval of a letter</i>

1. On 15 October 2025, the Commission submitted to the Council proposal for transfer of appropriations No DEC 18/2025, in accordance with Article 31(1) of the Financial Regulation¹.

As recorded in document 13971/25, the purpose of this proposal is to transfer a total amount of EUR 3.4 million in non-differentiated appropriations from Items 20 03 13 01 (*Translation expenditure*) and 20 03 09 01 (*Legal advice, litigation and infringements — Legal expenses*) to Article 20 10 01 (*Translation Centre for bodies of the European Union*).

2. In 2024, the Centre had a budget deficit of EUR 4.9 million. In the Centre's second amending budget for 2025, adopted by its Management Board on 16 October, the deficit has reached EUR 11.5 million, including the carry-over of the 2024 deficit. This will partially be covered by the Centre's Reserve for pricing stability (EUR 8.1 million), leaving a negative balance of EUR 3.4 million. Therefore, the transfer from the Commission is being proposed to allow the Centre to balance its budget for 2025.
3. The Budget Committee examined this proposal for a transfer at its meeting on 29 October 2025.
4. Following that examination, the Budget Committee agreed, by a qualified majority, to suggest that the Permanent Representatives Committee advise the Council to approve:
 - the proposed transfer of appropriations, as set out in document 13971/25, and
 - the draft letter in the ANNEX to that effect.
